



Pursuant to an Order by Chief Justice Mark E. Recktenwald and Orders by First Circuit Chief Judge R. Mark Browning filed on March 16, 2020 in response to the COVID-19 outbreak:

- **All HOPE probation hearings, urinalysis, face-to-face hearings, except essential hearings,** are postponed until after April 30, 2020. Adult Probationers, call your probation officer for further instructions.
- **Juvenile Probationers,** call your court officer for further instructions.
- **Criminal trials and grand jury proceedings** are postponed to a date after Thursday, April 30, 2020.
- **All face-to-face conferences, hearings and motions, except motions regarding bail and matters requiring urgent court action** are postponed until after April 30, 2020.
- For **all treatment courts,** all face-to-face hearings, except for essential hearings are postponed until after April 30, 2020.
- **Criminal Case hearings will still be heard for:**
 - Initial appearances and bail hearings in felony cases,
 - Preliminary hearings for in-custody defendants in felony cases,
 - Arraignment and plea and extradition hearings,
 - Mental Health proceedings held pursuant to HRS §704,
 - Proceedings that the presiding judge deems urgent.
- **Ongoing Trials:** All ongoing trials are postponed to a date after Thursday, April 30, 2020.
- **Civil trials and hearings** are postponed to a date after Thursday, April 30, 2020. This will not apply to proceedings on petitions for temporary restraining orders and other proceedings that the presiding judge deems urgent. In-person conferences shall be postponed and rescheduled for a later date. Contact the appropriate civil division.
- For **Foreclosure cases** assigned to Judge Castagnetti, all hearings motions will be rescheduled to after April 30 unless ordered by the judge.
- **To view court documents** in your current or recent circuit court civil, circuit court criminal, district court criminal, district court civil, or appellate case, you may purchase many of the documents online using eCourtKokua.
- **Probate cases:** All in-person hearings for matters before Probate Court are suspended until further notice. See detailed probate instructions filed in case # 1CSP-20-82.
